Minutes, Tuesday, January 19, 2010

In attendance: J. Larson, T. Hartman, D. Robb, B. Bigelow.

1. Meeting called to order.
2. Treasurer's Report (Hartman): \$2,800.00 in Trust Fund.
3. Old Town Hall: Work to be done on fire escape by Amherst Welding, to be completed by June 1, 2010.
4. Rob Keyes, Joe reports, says that he will furnish the Forms B with his historical descriptions and Bonnie's architectural descriptions (for the 20 homes in Phase III paid for by the Historical Society) by our next meeting (February , 2010,).
5. Recommended by Larson that we send a letter to R. Keyes asking that he compile descriptions for following addresses: 11,15, 19, & 38 S. Valley Rd., and moved that \$1000.00 be paid to R. Keyes upon completion of above work. Voted in the affirmative, all in favor.
6. With regard to the pending removal of the fish rod factory dam, Larson evinces that our main interest as a Commission is to have the dam thoroughly documented. General assent.
7. Discussion of possible grant sources for removal of dams, stream and river restoration – Trout Unlimited, NOAA, etc.
8. Also discussion of the possibility for obtaining grant monies toward the creation of an historical exhibit, documentary of the Pelham fish rod factory. Possible donors – Cabela's, L.L. Bean, etc.
9. Discussion of fact that the fish rod factory in Pelham was the first to have the machine to split the bamboo in a way that enabled efficient assembly of fishing rods.
10. Meeting adjourned.
