Selectmen are forming a committee, looking for additional office space and storage / vault space for all the town records. Joe also suggested to investigate the possibility of a position regarding genealogical research.

Insurance Linda Hanscom and Cathy Martel

Current situation: A meeting has to be sponsored by a town body and needs to be open to the public or the group needs to be insured to use any public building. It needs to be a business insurance if classes are held.

Museum: town meeting allowed PHS to use building as museum, our interpretation is that this is now a town sponsored event and all their activities are automatically covered. (unanimous voted)

Town Hall: town meeting, Easter sunrise service coffee, shape note singing (sometimes PHS), harvest supper. Position taken that we will cosponsor with PHS the harvest supper and Easter service coffee (open to public) and the shape note singing as ongoing historic activities.
