Mollye Lockwood made the motion to open the meeting at 4:41 PM. Tilman Lukas seconded the motion. All in favor.

Gail Kenny made the motion to accept the February 2, 2016 minutes as amended with the edits noted by Ruth Eclan. Ruth Elcan seconded the motion. All in favor.

Ruth Elcan made a motion to adjourn, seconded by Mollye Lockwood, all voted in favor and the meeting adjourned at 6:10 PM.

Committee Discussion Topics

Discussion of upcoming CPA conference this week and additional research by committee members on housing programs in other communities. Ruth noted that Goshen, Phillipston and Conway have prepared housing analysis reports that may be useful to the Committee. Goshen reviewed other elderly affordable housing developments (Cummington, Westhampton, Worthington) that are described in their report.

Tilman noted to the Committee that we need to make sure that we are not only looking at funding from CPA for possible programs.

Committee reviewed the draft of Connie's contract for her to prepare the RFP and assist the Committee to hire a firm for the CPA-funded, land inventory project.

Connie discussed with the Committee her thoughts on the best process for selecting the firm for the project. We can use a simple, phone bid process since the project cost is small, but, per state procurement regulations, this would necessitate us choosing the lowest bidder. Connie suggested, and the Committee agreed, that we should use the full RFP process where the Committee will use evaluation standards to select the firm for this project – and not just pick the firm based on price.

Gail updated the Committee on her research on Leverett affordable housing programs. The Select Board member with whom Gail spoke pointed Gail to the web site to see the forms for Leverett's down payment assistance/homeownership program. The Franklin County Regional Housing Authority manages the Town of Leverett's program.

The Committee discussed possible programs to assist qualified buyers with closing costs versus down payment assistance as a cost effective way to begin Pelham's housing assistance programs.

Committee reviewed Provincetown, MA "Little Fix Program" – could be small funding associated with the program and volunteers assisting – may be a good fit for Pelham.

Committee discussed that challenges for seniors staying in their homes involves both financial issues and providing services and assistance with maintaining their homes. At some point in the near future, Committee will invite Pelham Council on Aging to an upcoming meeting to discuss these and other issues for seniors remaining in their homes.

Committee began to discuss its mission statement.


