Reviewed final draft of Land Inventory report with DF.

- Barbara shared her comments with the team via flash drive since the doc was too big.
- Other comments included:
 - o Appreciation for DF for a great job on this report and for working so well with the Committee on the revision and editing process to get to this point today.
 - o Barbara suggested that a pie chart be done to show what land is protected/not protected.
 - o Tilman asked for clarification regarding property on Harkness Road that was noted on page 7 of the latest draft of the report. Nate will review and revise this language to be more clear regarding development potential.
 - Barbara added a new comment / change regarding a sentence on Page 13 that speaks to wetland buffer restrictions – clarifying what could be allowed in buffer zones in state versus local law.
 - o Barbara noted that the years for the citations in the report could be noted.
 - Improving the table of comments links included in PDF report, including pages for the maps.
 - Discussed what web site could host the final report for public access.
 - Requested the following final work products:
