Gail informed the Committee that the owners of a specific lot the Housing Committee has been considering as a possible site for a Habitat for Humanity home are willing to sell for that purpose. The lot will be temporarily referred to as Property X in order to maintain confidentiality until negotiations are concluded. Gail Kenny will coordinate a site visit with Habitat to confirm site suitability. If satisfactory, the Committee will seek an outside appraisal to help establish market value. Tilman will contact the town treasurer to determine if previously approved Community Preservation funds are still available to cover some of the initial review costs.

Committee reviewed final draft Contract with Valley Community Development Corp. (VCDC) for the Fist Time Homebuyer Program. Edits were previously provided to Tilman. He made changes and then forward to VCDC for their comments. Final draft will now be forwarded to the Select Board Administrator to forward to Town Counsel as per Motion.

Tilman informed the Committee that Sarah Hall, hopefully a future Committee member, is unable to serve on the Committee do the scheduling conflicts with her employment.
