**Rescheduling Annual Town Meeting & Election Dates**

Option to hold as scheduled or change before June 30<sup>th</sup>. Motion to postpone annual town meeting until 9am June 6 at the Pelham Elementary School and annual town election to Tuesday June 9 following

annual town meeting, unanimously approved. Early voting and absentee ballots will be available from the Town Clerk.

#### **Declaration of State of Emergency for Pelham & Department Staff Management**

Other surrounding towns declaring as preventative measure. Motion to declare state of emergency in Pelham, unanimously approved.

The Board of Selectmen agreed that department managers should use their own judgement on how to manage their staff and schedules during this time.

#### **Appointed Town Clerk Position**

Legislation was signed by the Governor to change the Town Clerk's position from Elected to Appointed. The incumbent, Kathy Martell, will serve the remainder of her term until May 2020 if she wishes to do so with the town (2019 Annual Town Meeting Warrant). Motion to appoint Kathy Martell as appointed Town Clerk for Pelham through June 9, 2020, or if election is postponed further, unanimously approved. Discussion that Kathy will remain working her same hours and will receive the same compensation.
