the 14th and be an active participant in town meeting.



Recently the legal Right of Way from the Amherst Town line to South Valley Road has been established. Thank you to Highway Superintendent Rick Adamcek for your guidance and moving that plan along.

Berkshire Design Group in conjunction with PVPC has begun survey work related to the sidewalk design along Amherst Road beginning at the town line and continuing East towards the Community Center. The design process will include public participation. The Select Board approved the use of ARPA funds for design costs associated with this project. When a design is approved we will seek grants to fund actual construction.

Pelham and Amherst now have an approved memorandum of understanding detailing the collaboration to design an extension of Amherst's public sewer lines to Cadwell Street, Jones and South Valley Roads (South Valley Road between Jones and Amherst Roads). The first step in the design process is to conduct a survey to mark the right of way on the affected public ways. Amherst has chosen a firm to conduct the survey and we look forward to this work beginning soon. The Select Board has approved ARPA funds for the design costs associated with this project. Once a design is agreed upon we will work with Amherst to obtain grant funding to implement the project.

UPDATES FROM THE SUSTAINABILITY COMMITTEE

The Pelham Sustainability Committee has been hard at work this year after the success of the What to Do With Your Stuff manual! Our goal is to identify concrete steps we can take to minimize the negative impact of how we use and dispose of natural and manufactured items in our daily lives. As a backdrop, we are witnessing and experiencing climate extremes, with fires, floods and extreme heat. These events spur us forward in our work.



This thinking and discussion has led us to the idea of zero waste! Zero waste goes beyond recycling and becomes a whole systems approach to eliminating waste in our communities. It is seen as one of the most important ways to combat climate change. As we all need support in making needed changes in our consumer habits to reach this goal, our latest endeavor was to sponsor a gathering called Moving Towards Zero Waste: Workshop and Strategy Swap. If you attended this gathering, you had a chance to see how helpful it is to be with others who are interested in taking action towards reducing our waste. Hopefully, everyone came away with great, concrete ideas and most importantly, inspiration! We are continuing to fulfill our mission of supporting each other in reducing, recycling, repurposing and reimagining how to handle our waste. PELHAM'S NEW DARKSKY BYLAW AND YOU

What is DarkSky?

Internationally, state-wide, and locally, DarkSky standards aim to protect wildlife and human health by reducing light pollution, while still ensuring that you have the light you need. At the spring Annual Town Meeting, Pelham voted in a new DarkSky bylaw. It's based on lighting standards developed by the prominent organization DarkSky International.¹

Why DarkSky?

Excess light disorients migrating hummingbirds and butterflies, discourages fireflies, and makes frogs too vulnerable to predators. That's just for starters. Excess light harms many of the insects, amphibians, birds,



and mammals that live with us in Pelham. That includes humans, with higher rates of cancer, heart disease, diabetes, depression, obesity, and sleep disorders where there's more artificial light. Excess light wastes energy and money. Glare can create the illusion of visibility while actually making it harder to see – especially for aging eyes. Plus it spoils stargazing, and could even annoy your neighbors! That's why more than 50

SCAMS THE IRS WANTS YOU TO KNOW ABOUT (FROM AARP)



Older adults are often targeted by criminals trying to extort money or identity information. You may have received a phone call from someone pretending to be from the Internal Revenue Service (IRS). They'll insist you have an unpaid tax bill and face arrest unless you pay up immediately. The fake appeals can also come by regular mail, email and text. A new twist involves scammers sending letters with the IRS masthead in a cardboard envelope from a delivery service. The letter says that the recipient is being contacted regarding an "unclaimed refund," and offers a phone number that is not the IRS's. The taxpayer is asked to disclose personal information — "including detailed pictures of <u>driver's licenses</u>," the IRS says, that can be used by identity thieves to try obtaining a tax refund and other sensitive financial information.

How can you protect yourself from SCAMS?

- Hang up when you receive a phone call claiming to be from the IRS.
- Ignore any unsolicited email, social media post, or text claiming to be from the IRS. The agency won't contact you via these methods.
- Beware of anyone who claims you are owed money by the IRS who hasn't actually reviewed your taxes.
- Never pay an upfront fee to someone who says they can get your money back.

Massachusetts municipalities have already enacted DarkSky-related legislation.²

Will I still have enough light?


Seeing your way around is important! DarkSky standards are compatible with keeping your property securely and safely lit. DarkSky's first statement about "responsible outdoor lighting" is that it "meets the needs of people to see at night." DarkSky standards were no off-the-cuff project. Rather, they draw on reams of published studies, and address the visibility needs of diverse populations, including the elderly and those with low vision. Local college campuses, residential developments, and homes have been lit effectively according to these standards. You can see photos of a few of these locations at the link noted below.

It can be a real shift to go from lighting up a property like a stadium to a softer glow. But doing so can actually improve functional visibility by keeping glare from washing out your vision. In terms of security, decades of studies find no conclusive link between lighting and crime. The standards ensure that light is on your path when and where you need it, not constantly spilling out or up into the sky. The warmer light tones are just as illuminating, but have less of a negative impact. If you can imagine walking under the full moon, compliant lighting is up to 300 times as bright, depending on the square footage that each fixture covers.

Many people wonder about the cost of DarkSky compliant lighting. When it's time for replacement or new lighting, good lights are no more expensive than bad ones – and, they'll actually save you money by minimizing wasted energy.

What's in the bylaw and what can I do?

Because of the importance of DarkSky's goals, recently affirmed in a town-wide survey, we were eager to get a bylaw on the books. Until consumer labeling for bulbs and fixtures catches up, some of the bylaw's technical specifications will be more relevant for professionally-led construction projects, and we do anticipate bylaw refinements over time. But the bylaw's principles, with their many immediate benefits, are already actionable. This illustration summarizes those principles in terms of the steps that improve lighting:

Shielding: Keep light from shining

from shining upwards. Direct light where you need it, and limit spillover in other directions.

Color

Temperature:

Choose amber - toned lighting rated 2700K or less. (Color version of illustration is at link below.)

Intensity:

Think soft glow, not glare.

Timing:

Use timers or sensors so light is on when you need it, and off when you don't.

Is the choice to support DarkSky up to me?

While we hope you'll want to support DarkSky standards, there's no light police coming to your door to check your pre-existing lighting. When there's new construction, and when you're replacing bulbs and fixtures over time, that's when it's critical to be cognizant of the bylaw. The building inspector can help with implementation questions. There are handouts at the library, and the planning board together with others will be looking into providing a community forum with an expert or other forms of assistance – watch the town website for updates.
