## FROM THE SELECT BOARD OFFICE

**In an effort to promote a clear and common understanding of our town's bylaw regarding the control of dogs, the Select Board is sharing this information directly by mail with all licensed dog owners and with all Pelham residents below.**

Article 22 that passed at the 2019 Annual Town Meeting is incorporated in the relevant sections of the bylaw shown below. It is now the current Town Bylaw and it stipulates that an unleashed dog running at large beyond the boundaries of its owner's residence is a violation of the bylaw unless the dog is in the act of training, working or hunting. Reported incidents of this and other enumerated violations are subject to fines as provided in the Fine Schedule, which was also amended at the 2019 Annual Town Meeting. While Article 23, which was defeated at the same Town Meeting, would have required that "dogs on Town property must be leashed at all times", Pelham's current bylaw requires that dogs be leashed when they are beyond their owner's property (with exceptions as enumerated).

**Thus, there is a leash law in Pelham. All complaints and alleged violations should be reported to the Dog Officer, (413) 800-6280.**

The current version of the bylaw posted in the Code of Pelham on the town website does not yet reflect updates from the Articles that passed at the 2019 Annual Town Meeting. It will be updated once the codifying process is completed. The following sections of the Animal Control Bylaw relevant to dog control incorporate the changes approved at the 2019 Annual Town Meeting.

### § 5-3 Purpose.

The town requires that all dog owners keep their dogs under control at all times for the purpose of protecting people and animals from injury, protecting property from damage and preventing dog-related nuisances. The Town further requires any dog for which one formal complaint has been filed be kept under the owners/guardians or keepers leash control at all times on town property.

### **§ 5-7 Violations enumerated.**

Any owner who allows his/her dog to do any of the following will be considered in violation of this article:

- A. Unlicensed dog: a dog six months or older, which is unlicensed or not relicensed by May 31 each year.
- B. Running at large: to go beyond the boundaries of the owner's residence unless the dog is under leash control; however, dogs in the act of training, working or hunting are excepted.
- C. To chase a pedestrian, bicycle or any other vehicle.
- D. To bark excessively during the day or to bark between 10:00 p.m. and 8:00 a.m. so as to disturb the reasonable quiet of the neighborhood.
- E. Worring livestock: to worry, injure or kill another's livestock, fowl or pet.
- F. Vicious dog: to menace, attack or bite a person without provocation.

## ANTI-RACISM ADVISORY COMMITTEE

**The ARAC has been working since the Fall of 2020** to examine the Town of Pelham's policies and bylaws through an anti-racist lens and provide feedback that both counters systemic racism and advocates for equity within our community. We currently have three open seats.

**Within ARAC, we have five working groups:** Outreach, Policy, History, Public Safety, and Education. These groups are addressing anti racism in several directions, such as fair housing, communication with our public safety officers, and drafting an anti-discrimination bylaw.



This last year we have made three recommendations to the

Select Board, one concerning Anti Racism training for town personnel, another supporting changes to the Mathematics curriculum, and one recommending the retention of an Intervention Teacher at Pelham Elementary.

We meet once a month, on Zoom, as a full Committee. The working groups meet as needed.

**While we are seeking Committee members, anyone interested in participating only in a working group is also welcome.**

## UPDATES FROM THE TOWN CLERK'S DESK

### CENSUS

The 2022 Annual Street Listing forms have either been mailed or will be shortly. Please complete the form according to the instructions provided and return at your earliest convenience.

### DOGS

An application to renew dog licenses by mail is printed on the reverse of the Annual Street listing form. **2021 Dog Licenses expire on March 31, 2022** and must be renewed by May 31, 2022 to avoid a late fee.

Any dog license renewed on or after June 1, 2022 will incur the late fee.

### LATE FEES

(per dog – in addition to the license fee)

Effective 6/1/21 - \$10 \* Effective 7/1/21 - \$25 \* Effective 8/1/21 - \$50

All dogs 6 months or older must be licensed annually.

### TO LICENSE YOUR DOG BY MAIL

⇒ SEND THE FOLLOWING:

- ◆ A copy of the current rabies vaccination certificate for each dog **if done less than a year ago.**
- ◆ Proof of neutering or spaying **if procedure done less than a year ago.**
- ◆ A #10 size SELF-ADDRESSED STAMPED ENVELOPE to return the license and tag.
- ◆ Check payable to "Town of Pelham" for the appropriate fee.

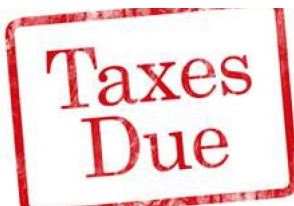

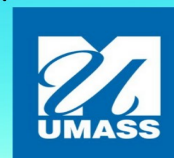

**New member:** Robert Redwood was appointed by the Select Board to the Board of Health on October 6, 2021. Bobby is a physician and Chief of Emergency Medicine at Cooley Dickerson Hospital. Bobby will have to run for a full-term next May. Pelham is lucky to have such a qualified member and hope he stays on the Board for many years. Bobby is replacing Chris Rice a long serving member who resigned due to a move. I want to thank Chris for his long service.

**Pioneer Valley Mosquito Control District:** Pelham voted to join the District at the Fall Special Town Meeting. With membership the Town can receive services which includes weekly mosquito trapping and testing while also reapplying to opt-out of the widespread pesticide spraying State program. Last Spring's application was rejected but with our membership in District our application should be more robust.

**COVID-19 PANDEMIC:** There have only been two cases of COVID reported since October 1 in Pelham and both appear to be connected to UMASS. There isn't an easy way to determine Pelham's vaccination rate since it is mixed in with Amherst which is further complicated by UMASS Students, but it appears to be over 80%. It's time to get booster shots and please still use masks.

## PROJECT SUSTAINABILITY WORKING GROUP



### WHAT TO DO WITH OUR “STUFF”?

Did you know that Pelham now has a new Project Sustainability Working Group? Born out of conversations with other townsfolk, and a very successful Swap Day held in the late spring, sponsored by the Democratic Town Committee, Pelham now has a new working group to help research the various ways we can reduce, reuse, repurpose and recycle our “stuff”.

**The pandemic has brought into sharp focus the issue of how to manage packaging, out of date products, no longer wanted items, etc.** During lockdown, our local transfer station shut down the “Take It or Leave It”, and Styrofoam was no longer collected. In other depositories such as supermarkets, plastic bag recycle bins were closed. Many of us collected these items in the anticipation that things would open as the pandemic impacts waned but there is a growing awareness that this is not entirely the case.

**The Take It or Leave It is not reopening, nor is the collection of Styrofoam for recycling.** The confusion around what plastic is recyclable is widespread and there are reports of recycling not being very effective. Our oceans are filling up with refuse from our lifestyle. Alarm bells are sounding about climate related issues and there is a growing awareness of how our lifestyle is impacting our ecosystem and climate. Now there is something we can do about it!

**Creation of the Project Sustainability Working Group is in line with the principles of the Transition Town movement** but few in town know Pelham is an official Transition Town! (Visit [transitionus.org](http://transitionus.org) for more information). Simply speaking, Transition is a movement of communities coming together to reimagine and rebuild our world. It is becoming clear that we can and must take things into our own hands as the easy and simple methods for managing our refuse that were once in place are changing. Pelham is now moving forward in manifesting the principles of Transition.

**The Project Sustainability Working Group’s initial vision and task is to create a document specific to Pelham, that explains multiple ways to reduce, reuse, recycle and reimagine what to do with our items.** We all know about recycling paper, plastic and cans. Our research will focus on other items that are not as easily disposed of such as CD/DVD cases, corks, stuffed animals, fabric/old unusable clothing, Styrofoam and so forth. Our manual will provide some guidance and concrete steps that are possible and serve as a beginning for our town to engage in making this a better world!

## FY2023 BUDGET SEASON

### Outline of the Budgeting Process:

**In November** representatives from each Town that make up the Regional school met to review the Region's Assessment methods and discuss each Town's unique financial situation. This marked the beginning of the budget planning process for the fiscal year 2023 which begins on July 1, 2022. The 4 Towns will meet again at a tentative date of January 8, 2022 to review the initial budget from the Regional School and discuss in more detail an assessment method that would be agreeable to all of the Towns. The 10 year Capital plan for the Region should be available for that meeting for review and discussion.

**On January 10, 2022**, the annual Roundtable will be held by a joint meeting of the Select Board and Finance Committee to provide guidance on budget preparation to all the departments, boards, and commissions and others who might be looking for money from the town in FY2023. We will also listen to any potential unanticipated requests.

**In February**, the Finance Committee will meet with each department, commission and board that will be requesting additional money in the new year. The last meeting will be the first week in March with the two schools to finalize their requests. At that time, we expect to complete the operating budget known as Article 3 in your Town Warrant.

**During March** the Finance Committee will review all Warrant Articles that are money related.

**In April**, we will meet with the Select Board and review Article 3 and all the financial warrant articles they are considering for the May Town Meeting.

The Finance Committee looks forward to seeing you on Saturday May 14, 2022.

At Fall Special Town Meeting, Pelham residents strongly supported spending \$250,000 of available CPC funds for the future development of Amethyst Brook Apartments at 20-22 Amherst Rd.

**We are also gratified to have received responses from 50 Pelham households to our Affordable Housing Survey.** If you were not at the Fall Town Meeting or did not have an opportunity to respond to this short 9 question survey (anonymously - no names), please pick one up at either the Rhodes Building or the Pelham Library.
